# ORGANIZATIONAL BUDGET OF LESS THAN \$2 MILLION



**ICU baby's** Transportation Assistance Program eliminates expensive home-to-hospital travel costs that often serve as a

barrier to parents visiting their baby in the Neonatal Intensive Care Unit (NICU). Bus passes, gas stipends, parking vouchers or private transportation are provided to low-income families so that parents can be present in the hospital and engage in their baby's NICU care. This Program has helped over 300 families get to the hospital, week-after-week, to be with their baby.



**Miami Music Project** uses music as an instrument for social transformation, empowering Miami's children to achieve their full potential. For over a decade, they have

impacted the lives of more than 30,000 underserved children living in Miami, providing the tools necessary to reach their academic goals and build their confidence. Throughout the COVID-19 Pandemic, they remained steadfast in fulfilling their mission, implementing a virtual program to ensure the families served still had access to the life changing power of music.



UNIVERSITY OF MIAMI MILLER SCHOOL OF MEDICINE

**Wolfson DOCS** is a community service program run by medical students from the UM Miller School from Medicine. We seek to provide care to the medically

underserved patient populations of South Florida through our health fairs and clinics. Over the last few years, we have pioneered innovative ways to transform how we deliver care. Most notably, our organization implemented our very own novel electronic medical record system allowing for real-time identification of high-risk patients as well as tracking patient results.

**Bigs in Blue** matches youth (Littles) one-on-one with law enforcement officers who serve as mentors (Bigs). The program increases public safety through the lens of positive relationships, enabling all youth to achieve their full potential. With the vast majority of program youth coming from minority backgrounds, these relationships address the inequities, biases and lack of trust between law enforcement and urban communities, developing and strengthening trust and thereby improving the critical relationship between police officers and the communities they serve.



For 25 years **Chapman Partnership** has operated as a nationally recognized homeless assistance model; today providing comprehensive programs from early childhood-to-career. Using forward-thinking approaches, we address homelessness with education and empowerment. Identified as a best in class approach to increasing economic opportunity for individuals experiencing homelessness, Chapman Partnership is key to changing the upward trajectory of a highly vulnerable population, making their financial lives better through the power of connection while contributing to the economic recovery of our local economy.



**SEED Miami** is a college-preparatory, public boarding school for South Florida's under-resourced youth. SEED provides an outstanding educational program that empowers students to be successful, both academically and socially, in college and beyond. This is a milestone year where we will move into our dorms with our Founding Senior Class on the verge of college enrollment.
